Airlift NW speaker was a flight nurse by the name of Katie, they plan to start operations in our District on 06/24/2022. There is no reciprocity with Lifeflight because Airlift NW is a public agency and Lifeflight is privately owned. The State Attorney General will not let them intermix funds. Some Fire Districts are choosing to carry both plans. The speaker mentioned that dispatch is utilized to toggle calls between the two companies in Wenatchee. At the Chief's conference, Chief Bucy spoke with Lifeflight for an hour and Airlift NW for about 20 minutes. Both were concerned with no operational plan in place. Chief Bucy will get ahold of Sam and follow up to see where all of this is at. Commissioner Wells will call on Tuesday to the director of Dispatch and the Sheriff to put this on hold until further discussion. Will hold until next meeting.
