# **CHIEF'S REPORT**

Mobilization/Wildland -

Ford/Corkscrew should be in patrol status by the 14<sup>th</sup>. IR teams were able to go in 50' around the 48 mile perimeter, which is very impressive. DJ Green the DNR Arcadia Manager has been doing a great job. No major flair ups. When it moves to patrol status it will be checked twice a day, it will be burning until a significant weather event.

Cari and I will be on mobilization for likely 7-10 days on the Muckamuck Fire in Omak. Jason Gallagher's assignment with a type 2 team as a structure protection specialist on the 25 Mile Fire in Chelan is a good opportunity for training.

Question from Commissioner Lee;

- Q. What are the plans for Engine 2?
- A. Enduris has given permission to move it. We are waiting on approval to remove a few items pending the Salvage Value assessment.

We have had one Firefighter/EMT request to be changed to a tender operator as they do not want to be vaccinated. The deadline to submit an exemption request is 1700 on the 9<sup>th</sup>, so we will have a better picture by Monday on where we are at with all of it.

## b. Stevens County Fire Commissioners Matters -

There is no mandate on how many meetings are to be held. The meeting does not have to be held in the District that is up for rotation if accommodation cannot be found. A message will be sent out to the District with an update.
